UNOPPOSED MOTION TO AMEND DEADLINE FOR MOTION TO STRIKE

The LSP Board requests that the current date for the filing of a Motion to Strike be extended by one week. The requested schedule would be as follows:

Responses to Motion for Oral Testimony	Unchanged: October 1, 2010
Petitioner's Rebuttal Testimony	Unchanged: On or before October 8, 2010
Motion to Strike	October 15, 2010
Opposition to Motion to Strike	October 22, 2010
Hearing	Unchanged: On October 27, 2010 from 9 a.m. to 4 p.m. at the Boston Office of the Department at One Winter Street, 2 nd Floor, with provision for a second day of hearing if necessary on October 29, 2010

As grounds for this motion, Lynn Read, prosecuting attorney for the LSP Board, states the following:


1) In the prior Motion to Amend Scheduling Order by one week, I inadvertently omitted to request an adjustment to the deadline for any Motion to Strike that the Board might believe is necessary. Thus a Motion to Strike would currently be due on the same date that the Board's Rebuttal testimony is due, October 8, 2010.

2) Between September 22 and October 8, 2010, I will need to coordinate with the Board's four witnesses in drafting any Rebuttal testimony, and during the same time period, I must respond to Respondent's Motion for Oral Testimony by October 1. Thus I will not be able to draft a Motion to Strike in the same time period.

3) Therefore, I am requesting a one-week extension of the deadline for a Motion to Strike. I provided Mr. Decoulos with this motion and he informed me that he has no objection to it.


